SCHOLARSHIP INFORMATION

To honor the contributions in the area of leadership of one of our pioneering and respected colleagues, the Debbie Fox PACT was established. This fund allows the KRCS to mentor future leaders. The Debbie Fox PACT is given annually to a respiratory therapist who desires to attend the AARC Capitol Hill Advocacy Day and become an active member of the Political Advocacy Contact Team (PACT) on the state and national levels.

SPONSORSHIP INCLUDES:

- Meet with a KRCS board member to discuss current legislative activities.
- A graduate from a COARC accredited respiratory care program and employed within the respiratory care profession.

- You will provide receipts for travel (airfare, ground transportation, and lodging) to the KRCS Treasurer for scholarship reimbursement.
- You will be representing the KRCS at the PACT meetings. Therefore, you must show up on time for meetings, dress appropriately (business), and conduct yourself professionally.
- You are required to submit content to be posted on the KRCS social media platform, about the PACT visit.
- You will be required to deliver up to a fifteen-minute presentation during the KRCS State Conference in April about your experience.
